### Group MSME Programme

Applications are invited for establishing group MSME units with an outlay of Rs.25.00 Lakhs with Rs.10.00 Lakhs as grant, Rs. 5.00 Lakhs as Beneficiary contribution and remaining Rs.10.00 Lakhs from Banks across AP by a group consisting of 3 to 5 Members.

#### **Eligibility**

- The income for each member of the group should not exceed Rs.6.00 lakhs.
- The group should set up enterprise in AP.
- The members of the group should be between the age of 21 to 50 years of age at the time of applying for the programme. Any of the Members of the group should not be defaulters to any Bank or any financial institution.
- The members of the group should not have availed any amount under any other Govt Programme for the same purpose.

#### **Application Procedure**

- Eligible groups should fill the application online at [kapucorp.ap.gov.in](http://kapucorp.ap.gov.in) in the prescribed format.
- The group shall upload the scanned copies (in PDF format of min.50kb and max. 150kb size each) of self attested copy of the following documents for each of the members of the group
  - 1) Income Certificate
  - 2) Aadhar Card
  - 3) Caste Certificate issued by competent Authority
  - 4) Date of Birth Proof
  - 5) SSC pass Certificate
  - 6) PAN Certificate
  - 7) Passport Size Photo graph

- 8) Savings Bank Account Statement of all the members of the Group separately.
- 9) Self affidavit by each member declaring that he/she is not a defaulter to any banks or financial institution.
10. Declaration by the group with signature of all the members about arranging the margin money of Rs.5.00 Lakhs in case of approval of their candidature.

### **Selection Process**

- Selection will be based on qualification, experience, aptitude, viability of the project, coordination between the group members.
- Interview will take place on group basis as it is a group activity and it will be essential to test the amicability of the members of the group and their chemistry.
- Selected candidates or group will be given one week time to inform their consent.
- After receiving their consent, final list will be prepared by corporation and selected list along with wait list will be placed in the website of the corporation.
- Selected Entrepreneurs will have to undergo a mandatory Entrepreneurship development programme (EDP) training conducted by NABCONS for a period of three days at District headquarters and a certificate will be issued to the candidates / groups.

### **Financial Model:**

- Cost of the project will be a minimum of Rs. 25.00 Lakhs.
- A subsidy of Rs. 10.00 lakh will be provided by the Corporation.
- Beneficiary contribution in terms of margin money for the project will be a minimum of Rs. 5.00 Lakh.
- The remaining balance shall be availed as Bank Loan
- Detailed project reports will be prepared by NABCONS as per project requirement in consultation with the groups.

### **Registration of Entity**

- Entrepreneurs shall form partnership firm and get the firm registered with appropriate authority.
- Bank Account shall be opened for the registered unit and margin money shall be deposited in Bank Account
- Subsidy from the Corporation will be released into this Bank Account.
