ORDER :-

In the reference 3rd read above, orders were issued directing the District Collectors to issue clear instructions to the Revenue Inspectors for issue of Caste Certificate, Income Certificate to the applicants of Kapu (Kapu, Telaga, Baliya & Ontari) communities.

2. In the reference 2nd read above, the Managing Director, A.P State Kapu Welfare and Development Corporation Limited, Vijayawada has informed that during the course of time it has been observed that the facility being provided is being misutilized by some of the beneficiaries as well as by the issuing authorities and many complaints are being received in the matter and further informed that to check the above malpractices, he has requested the Government to consider the Tahsildar as the issuing authority instead of Revenue Inspectors for issuing Caste / Income Certificate and uploading Caste / Income certificate received through E-Seva service only as followed in other welfare departments and further requested to issue an amendment to the Govt., orders 3rd read above.

3. In the reference 6th read above, the Director, B.C.Welfare while forwarding the letters received from the Chief Commissioner Land Administration, AP, Vijayawada and District Collector, West Godavari, wherein they have requested to revise the Govt. orders 3rd read above and requested to issue suitable orders in the matter.

4. In the reference 7th read above, the Revenue Department have also forwarded the file for issuing suitable amendment on the request of the Collector, West Godavari District to the Govt. orders 3rd read above.

5. After careful examination of the entire matter, Government hereby authorize only the Tahsildars to issue Caste and Income Certificate instead of Revenue Inspectors to the Kapu (Kapu, Telaga, Baliya & Ontari) communities by withdrawing the Govt. orders 3rd read above.

6. The Managing Director, A.P State Kapu Welfare and Development Corporation Ltd., shall take necessary action.
